



EQUIPMENT DAMAGE RESPONSIBILITY AGREEMENT

This Equipment Damage Responsibility Agreement ("Agreement") is entered into between **Jai Pix, LLC** ("Company") and the undersigned Client/Renter ("Renter").

1. RESPONSIBILITY FOR EQUIPMENT

The Renter acknowledges that all equipment provided by Jai Pix, LLC, including but not limited to the photo booth, camera equipment, lighting, props, backdrop, tablets, cables, and accessories, remains the sole property of Jai Pix, LLC.

The Renter accepts full responsibility for the care and security of all rented equipment from the time it is delivered, set up, or made available for use until it is retrieved by Jai Pix, LLC. This responsibility shall continue during the event and for a period of up to **forty-eight (48) hours** following the conclusion of the event if the equipment has not yet been retrieved.

2. DAMAGE, THEFT, OR LOSS

The Renter agrees to be financially responsible for any equipment that is:

- Damaged due to misuse, negligence, abuse, or intentional acts;
- Lost or missing;
- Stolen;
- Vandalized; or
- Destroyed while in the Renter's possession or under the Renter's responsibility.

The Renter agrees to reimburse Jai Pix, LLC for the full cost of repair or replacement, including labor, shipping, taxes, and any related expenses necessary to restore or replace the equipment.

3. REPORTING

The Renter agrees to notify Jai Pix, LLC immediately of any damage, theft, or loss involving the equipment.

4. LIMITATION OF RESPONSIBILITY

Jai Pix, LLC shall not be responsible for damages resulting from the actions of guests, vendors, venue staff, or any third party. The Renter assumes responsibility for ensuring that the equipment is used safely and is protected throughout the rental period.

5. SECURITY DEPOSIT

- A refundable security deposit of **\$250.00** is required at the time of booking and must be paid before the equipment is delivered or set up.
- The security deposit may be applied toward any necessary repairs, replacement of damaged, lost, or missing items, excessive cleaning, or any unpaid balances.
- If no damages, losses, or additional charges occur, the remaining deposit will be refunded within **two (2) business days** after all equipment has been returned and inspected by Jai Pix, LLC.
